

NOTICE OF PUBLIC COMMENT PERIOD

SANTA SUSANA FIELD LABORATORY GROUP 1B REMEDIAL INVESTIGATION REPORT SIMI HILLS, VENTURA COUNTY

The Department of Toxic Substances Control (DTSC) invites you to review and comment on the Group 1B Remedial Investigation Report (RI Report), previously referred to as the Group 1B Resource Conservation and Recovery Act Facility Investigation Report. The document name has changed under the statutory requirements of SB 990, which shifted Santa Susana Field Laboratory (SSFL) regulatory oversight to Chapter 6.8 of the California Health and Safety Code.

This report summarizes the results of chemical investigations of surficial media (soil, soil vapor, surface water, and shallow groundwater) performed in the Group 1B Reporting Area, located in the southeastern portion of Area I at SSFL. The Group 1B Reporting Area includes the Area 1 Burn Pit, the Bowl Test Area, Component Test Laboratories III and V, the Perimeter Pond, and the R-1 Pond.
